C O N T R A C T.

CONTRACT made and concluded the TENTH DAY OF DECEMBER, ONE THOUSAND EIGHT HUNDRED AND NINETY-FIVE, by and between OGDEN GOELET, ESQ., PARTY of the FIRST PART, and WILLIAM H. JACKSON & COMPANY, PARTIES of the SECOND PART, as follows:--

The said PARTIES of the SECOND PART COVENANT and AGREE to and with the SAID PARTY of the FIRST PART to furnish and erect in the residence of the said party of the FIRST PART Newport, R. I., IRON GRILLE and DOORS, with PLATE GLASS in SWINGING FRAME ON INNER SIDE OF GATE as per estimate of NOVEMBER 13th for-----\$4480.00

Also to REFINISH and REPOLISH at the house the iron work, and COVER SAME WITH PREPARATION FOR PREVENTING RUST, including the GRILLE on MEZZANINE LANDING. TWO DOORS TO PORTE-COCHERE, AND SMALL WINDOW GUARD AND GRILLE ON FIRST FLOOR ENTRANCE ON SECONDARY STAIRS, AND ALL THE GRILLES IN DOORS AT THE MAIN ENTRANCE as per estimate NOVEMBER 13th, for-----\$298.00, 3.00.

Also to furnish the POLISHED OVAL DOLPHIN GRILLE, per estimate of NOVEMBER 19th, 1895, for special price \$500.00.

ALL THE ABOVE TO BE EXECUTED IN THE MOST THOROUGH AND WORKMANLIKE MANNER, and set up in house before May 1st, 1896.

And the said party of the FIRST PART COVENANTS and AGREES to pay unto the said parties of the SECOND PART for the thorough execution of the same the sum of \$5278.00. (FIVE THOUSAND TWO HUNDRED AND SEVENTY- EIGHT DOLLARS) lawful money of the United States, same to be paid as work progresses



AND THE PARTIES TO THESE PRESENTS BIND THEMSELVES  
EACH UNTO THE OTHER.
