VI. Dr. John Quinn: Core Curriculum Review Committee Unofficial Proposal: Allow UNV 101 & 102 to both carry a theme.

- **Motion: The Faculty Assembly should waive the 30-day requirement.**
- **Question:** Will there be a test-out option? **Answer (Dr. John Quinn):** Not this year. Committee will revisit in AY 2016-2017.
- **Question:** Does committee have prerogative to decide on test-out option? **Answer (Dr. John Quinn):** No. With personnel changes there wasn't time to implement the test this year.
- **Representative Comments:** 1. We should know theme designations before advising; 2. The committee initially chose one UNV seminar to carry theme, allowing more courses to count for the core. 3. We don't understand the relationship between Core Review Committee and Curriculum Committee when it comes to vetting motions and bringing motions to assembly for a vote.
 - **Did not pass: 11% (yes), 75% (no) 15% (abstain)**
 - **Recommendation: Core Review Committee and Curriculum Committee should discuss procedure for bringing these matters to the faculty.**

VII Dr. Emily Colbert Cairns: Motion/Vote: Adjunct Faculty Profiles in Faculty/Staff Directory

- **Motion:** The Faculty Assembly proposes that adjunct faculty profiles be added to the Faculty/Staff Directory. This would facilitate communication between department chairs, students, advisers, and adjunct faculty. It would also provide adjunct faculty members with a profile to which they can link a curriculum vitae.
- **Representative Comments:** 1. We may not want to be transparent about the number of faculty we rely on; 2. We want to create an inclusive/collegial environment for all members of the teaching community.
 - **Passed: 83% (yes) 13% (no) 3% (abstain)**
