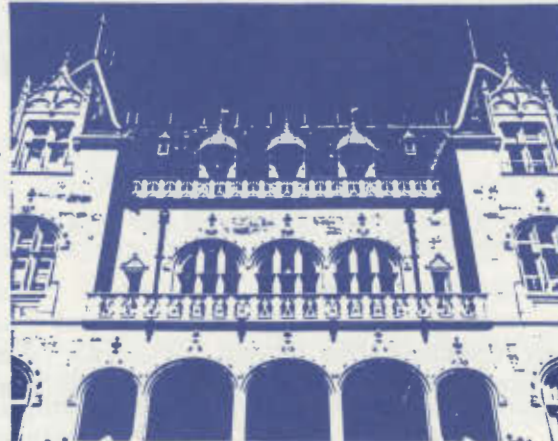

**SALVE REGINA FRESHMAN CLASS LARGEST
IN COLLEGE'S 40 YEAR HISTORY -
APPLICATIONS FOR ADMISSIONS AT RECORD LEVEL**

Fall classes began at Salve Regina on Thursday, September 10. In addition to marking the beginning of the school's 40th year, the day historically reflected the admittance of the largest freshman class since the College's opening in 1947.

Undergraduate applications for admission to Salve Regina College reached a record high this year, increasing more than 30% over the previous year. In addition, applications to nine graduate programs offered at the College increased 50%.

Although the College cites many reasons for the increase in applications, Sister Lucille McKillop, President of Salve Regina, said, "We attribute the increase in applications to the fact that Salve Regina has established a reputation for offering quality academic programs on both the undergraduate and graduate levels."

DEVELOPMENT OFFICE ANNOUNCES RECEIPT OF GRANTS

Salve Regina's Development Office has announced the receipt of three grants during the summer months. A \$20,000 check was received from the Fred M. Roddy Foundation, Inc. to be applied toward nursing scholarships. This amount represents the first installment of a grant totaling \$40,000 which was awarded in the spring of 1986.

A check for \$2,500, to be used for general support, was received from the New York Community Trust, and a \$1,200 grant award from the Providence Journal Foundation was applied toward the Salve Regina Scholarship Fund. The Foundation requests that first preference be given to qualified sons and daughters of employees of the Providence Journal Company and its subsidiaries.

Richard Dukeshire, the men's varsity basketball coach at Salve Regina, has accepted a coaching position in the Greek National Basketball Association. Mr. Dukeshire previously coached the Greek National Team and was asked to take this position while touring Greece with the Greek American Association (AHEPA) Basketball Team.

During his two years at Salve Regina, Coach Dukeshire compiled an overall record of 22-25, and his teams were runners-up for the Commonwealth Coast Conference Championship.

The award program offers recognition to superior students who excel in the academic disciplines. Her name will appear in the Academic All-American Collegiate Directory, which is published nationally.

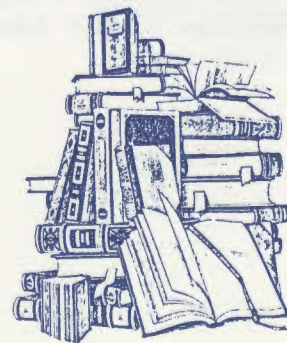

Stephen Rusyn, Ph.D., both members of Salve Regina College's English Department, attended a Literacy Conference subtitled "Student Writing: From Literacy to Literature." The conference was held at the University of San Francisco, and some of the topics discussed were the Literary Elements of Student Writing, Student Texts and Computers, Critical Theory and Theory of Composition, Computer as Reader, and Using Computers to Respond to Student Writing.
