SALVE REGINA COLLEGE RECEIVES
CASE GRANT FROM GULF OIL CORPORATION

Salve Regina College yesterday,

July 26, 1965, received a cash grant for unrestricted use from Gulf Oil Corporation.

It was one of 584 awards, totalling

\$595,500 that Gulf will distribute this year as direct, unrestricted grants to as many Universities and Colleges under its Aid-To-Education Program.

In addition to direct grants, the other phases of Gulf's comprehensive Educational Assistance program include capital grants; Gulf merit scholarships to children of employees and annuitants; employee gift-matching to colleges; departmental assistance grants; graduate fellowships; and faculty supplementation grants.

Institutions eligible for direct grants are those which are privately operated and controlled, and which obtain a major portion of their financial support from non-tax sources.

The amount awarded to Salve Regina College was \$500.00, and the check was presented to Sister Mary Emily, R.S.M., President, by Mr. Thomas F. Falconer, Area Sales Manager of Gulf Accompanying Mr. Falconer was Mr. Jerome Kirby, Sr., the Gulf representative in Newport.

This is the second year such a grant has been received from Gulf by Salve Regina. In each case the money has been used for the furnishing of a student room in Wiley Hall, the college's new residence hall and student center, with an appropriate plaque marking the contribution in the rooms so furnished.
