### INTERGOVERNMENTAL PERSONNEL ASSIGNMENT

Sister Lucille McKillop has received word from the Office of Senator Claiborne Pell that Dr. Charles A. O'Connor, Assistant Regional Commissioner of Education in Region II has been assigned to Salve Regina College under the Intergovernmental Personnel Act of 1970. Dr. O'Connor will continue in the employment of the Federal Government but will spend the next two years as a Visiting Professor at SRC. His particular responsibilities, assigned by the College President, will be in research, planning and program development, particularly in the fields of life long learning and community involvement.

In making the announcement regarding Dr. Charles O'Connor, Sister Lucille stated that the College was especially indebted to Senator Pell for his part in assisting with this Intergovernmental Assignment. Senator Pell is Chairman of the

Senate Sub-Committee on Education and was instrumental in Dr. O'Connor's appointment to Salve Regina College.

Temporary intergovernmental assignment under provisions of Title IV are known as Personnel Mobility Assignments. Mobility assignments are among the most innovative tools available to education.

Dr. O'Connor, a native of Rhode Island, has held several positions of educational leadership both in the state and nationally. He is a former superintendent of schools in Warren, Newport and Providence. Following his superintendency in Providence, Dr. O'Connor was appointed Assistant Federal Commissioner of Education for the New York and New Jersey areas.
